
**On the same day 12 I show that the Patent is true in 2 different ways:**

2- Finding the Patent on the Official European Patent Website.






## July 13




**The same day, July 13**




## The same day, July 13



## July 14






## The same day, July 16

Fabián Carvia Devereux interviews me from Argentina, in his radio program El que Sirve a la Madre, broadcast every Saturday live at 3:00 p.m. Argentine time (8:00 p.m. Spanish time) on [RadioLaSeñal 97.7FM](https://www.radio.la-senal.com) (I publish the interview 2 days later, the day 19).

**It is the first information medium that gives voice to the issue and seriously echoes research.**

### HIGHLIGHT

During the interview, I talk about a personal empirical study, (undocumented) carried out on almost 50 people, **all NOT vaccinated against Covid**. The study includes statistically different people; from babies, to the elderly, people from the city, people from the countryside, people who take medication, people who do not, people who eat healthy, people who do not, and so on.

40 of the 50 people analyzed, I was able to verify magnetism mainly in the chest, and in some cases magnetism in higher areas, such as the neck, forehead, and head in general.

**This means that 80% of the analyzed subjects report magnetism, of greater or lesser intensity.**

At [this point, dated July 20](#) (9 days after the first patent was posted) we can see some opinions, and I quote verbatim by making copy paste:



With what having 20,000 customers to sell graphene to be used for the manufacture of products of all industries, **means HUNDREDS OR THOUSANDS OF MILLIONS of products manufactured with Aqueous Solutions with Magnetic Graphene since 2009.**

Products that are NOT medical products, have also been entering our body through various routes, such as skin or inhaled, since we do not know for sure which products have been manufactured with these aqueous bases, and which ones. Since there is no regulation on this, manufacturers are not required to specify it.

The graphene in these Aqueous Solutions can be in 2 forms;
